Introduction

Welcome to the second stage of public consultation in the development of a public realm strategy for Portumna town centre. The purpose of this strategy is to ensure that Portumna can develop as a sustainable, vibrant and attractive place to live in, work at, to visit and invest. This public realm project forms a key element of an on-going partnership between Galway County Council, Fáilte Ireland and a number of sister state agencies, who are working to develop and promote Portumna as a key destination hub within Irelands Hidden Heartlands.

The Process

An initial public consultation took place in early 2023 and having taken your feedback on board the design team have developed a number of proposals, which are now presented for your consideration. The public realm project extents is indicated on the map below; while an extensive wayfinding strategy will also extend into the wider town and recreational areas as part of this exciting project.

Stage One Public Consultation

An initial consultation was undertaken to canvass the views of the local community and to help establish which issues relating to Portumna were important and why. The consultation comprised a short questionnaire and information package hosted on our dedicated consultation portal and was publicised through social media and local print. With 75 responses, a number of important findings emerged from the first public consultation, a summary of which is seen below. Your comments and observations have been taken on board in developing an exciting vision for the future of Portumna town centre.



Improvements include; flexible space suitable for events/markets similar to Somers Park Castlerea; car parking re organised; High guality natural stone paving to footpaths; reconfiguration of street furniture/equipment; Underground overhead lines; Enhanced contemporary street lighting. Relocated toilet block and bicycle hub to cater to cycleway users.
