NOTICE OF THE PROPOSAL TO MAKE THE LOUGHREA DRAFT LOCAL AREA PLAN 2024-2030

Notice is hereby given that Galway County Council pursuant to Section 20 of the Planning and Development Act 2000 (as amended), Article 14 A-E of the Planning & Development (Strategic Environmental Assessment) Regulations, 2004 (as amended), Article 6 of the EU Habitats Directive (92/43/EEC) and the Birds Directive (79/409/EEC) as amended, and the European Communities (Birds and Natural Habitats) Regulations, 2011 (S.I. 477) has prepared a Draft Local Area Plan (LAP), Local Transport Plan (LTP), a Strategic Environmental Assessment (SEA) Environmental Report, an Appropriate Assessment (AA) Stage 2 Natura Impact Report and also a Strategic Flood Risk Assessment (SFRA) for Loughrea.

The Draft Local Area Plan along with the reports outlined above will be on public display and may be inspected from Friday 24th November 2023 to Monday 15th January 2024 (excluding weekends and public holidays) at the following locations:

You should ensure that no vexatious, libellous or confidential information, including confidential information relating to a third party (in respect of which the third party has not, expressly, or impliedly in the circumstances, consented to its disclosure) is included in your submission. The Planning Authority reserves the right to redact any submission or part thereof that does not comply with this requirement. Please be advised that the submission will be published in full; Galway County Council is subject to the provisions of the Data Protection Act (as amended) and General Data Protection Regulation (GDPR). In order to assist us in complying with Data Protection and GDPR please include your name and contact details (and where relevant, details of any organisation, community group or company etc., which you represent), on a separate sheet to the content of your submission/ observation. This processing of your personal data is lawful under Article 6 (1)(e) of the GDPR regulations. The Council's Data Protection Policy is available on the Council website.

Please note that in accordance with Section 19 of the Planning and Development (Amendment) Act, 2019 all valid submissions received by the Council shall be published on the Galway County Council website within 10 working days of its receipt by the Council. The planning process is an open and public process and therefore your submission (in part or in total) will be available to view online at <https://consult.galway.ie/>. All observations or submissions received during the above time period will be taken into consideration before the making of the Loughrea Local Area Plan 2024-2030.
