FÓGRA FAOIN TOGRA I DTAOBH DRÉACHTPHLEAN LIMISTÉIR ÁITIÚIL AN GHOIRT 2025-2031 A DHÉANAMH

Tugtar fógra leis seo gur ullmhaigh Comhairle Chontae na Gaillimhe, de bhun Alt 20 den Acht um Pleanáil agus Forbairt, 2000 (arna leasú), de bhun Airteagal 14 A-E de na Rialacháin um Pleanáil agus Forbairt (Measúnacht Straitéiseach Timpeallachta), 2004 (arna leasú), de bhun Airteagal 6 den Treoir ón Aontas Eorpach maidir le Gnáthóga (92/43/CEE) agus de bhun na Treorach maidir le hÉin (79/409/CEE) (arna leasú), agus de bhun Rialacháin na gComhphobal Eorpach (Éin agus Gnáthóga Nádúrtha), 2011 (I.R. 477) na tuarascálacha seo a leanas i leith an Ghoirt: Dréachtphlean Limistéir Áitiúil, Plean Iompair Áitiúil, Tuarascáil um Measúnacht Straitéiseach Timpeallachta, Tuarascáil Tionchair Natura Chéim 2 ar mhaithe le Measúnacht Chúil a dhéanamh, agus Measúnacht Straitéiseach ar Phriacail Tuile.

Beidh an Dréachtphlean Limistéir Áitiúil, mar aon leis na tuarascálacha a luaitear thuas, ar taispeáint go poiblí agus féadfar breathnú orthu ón Déardaoin an 9ú Eanáir 2025 go dtí 4pm an Déardaoin an 20ú Feabhra 2025 (gan an deireadh seachtaine ná laethanta saoire poiblí san áireamh) ag na háiteanna seo a leanas:

Cuirfear san áireamh aighneachtaí nó tuairimí i scríbhinn maidir leis na doiciméid thuasluaite sula nglacfaidh Comhairle Chontae na Gaillimhe an Plean, ach iad a chur chuig an Údarás Pleanála le linn na tréimhse sin. Tá fáilte freisin roimh aighneachtaí nó tuairimí ó pháistí agus ó ghrúpaí nó cumainn a dhéanann ionadaíocht do leasanna páistí.

Is é Dé Déardaoin an 20ú Feabhra 2025 ag 4.00pm an dáta deiridh le haghaidh Aighneachtaí nó Tuairimí.

Ní ghlacfar le haighneachtaí déanacha.

Bheimis buíoch díot ach d'aighneacht nó do thuairim a sheoladh trí mheán amháin, is é sin go leictreonach nó i gcóip chrua.

Maidir le haighneacht nó tuairim a chur isteach, tabhair ar aird le do thoil:

- Tá páistí nó grúpaí agus cumainn a dhéanann ionadaíocht do leasanna páistí i dteideal aighneachtaí nó tuairimí a dhéanamh maidir le cuspóirí beartais chun straitéis fhoriomlán a cheapadh maidir le pleanáil chúil a dhéanamh i limistéir an Plean Limistéir Áitiúil agus forbairt inbhuanaithe a dhéanamh ann.
- Tá Comhairle Chontae na Gaillimhe faoi réir fhorálacha an Achte um Shaoir Faisnéise (arna leasú). Tabhair do d'aird le do thoil go bhfoillseofar ar líne gach aighneacht a gheofar, de réir cheanglais an Achte Pleanála.
- Ba cheart duit féachaint chuige nach n-áireofar san aighneacht uait aon fhaisnéis chráiteach, aon fhaisnéis chlúmhilleach ná aon fhaisnéis faoi rún, lena n-áirítear faisnéis faoi rún a bhaineann le tríú páirtí (nár tholligh an tríú páirtí, go sainráite nó go hintuigthe sna cúinsí, lena nochtadh). Coimeádann an tÚdarás Pleanála chuige féin an ceart chun faisnéis a chur i bhfolach in aon aighneacht nó cuid d'aighneacht nach gcomhlíonann an ceanglas sin. Tabhair do d'aird le do thoil go bhfoillseofar an aighneacht ina hiomláine; tá Comhairle Chontae na Gaillimhe faoi réir fhorálacha an Achte um Chosaint Sonraí (arna leasú) agus an Rialacháin Ghinearálta um Chosaint Sonraí (RGCS). Chun cabhrú linn an tAcht um Chosaint Sonraí agus RGCS a chomhlíonadh, bíodh d'ainm agus do shonraí teagmhála (agus, nuair is cuí sin, sonraí aon eagraíochta, aon ghrúpa pobail nó aon chuideachta etc., a ndéanann tú ionadaíocht dó nó di), ar bhileog ar leithligh a bheidh ag gabháil leis an aighneacht nó an tuairim uait. Tá an phróiseáil sin ar do shonraí pearsanta deathach faoi Airteagal 6(1)(e) den Rialachán Ghinearálta um Chosaint Sonraí. Tá Beartas Cosanta Sonraí na Comhairle ar fáil ar shuíomh gréasáin na Comhairle.
- Tabhair do d'aire gurb amhlaidh, de réir Alt 19 den Acht um Pleanáil agus Forbairt (Leasú), 2019, go bhfoillseofar gach aighneacht bhaill a gheobhaidh an Chomhairle ar shuíomh gréasáin Chomhairle Chontae na Gaillimhe laistigh de 10 lá oibre ón uair a gheobhaidh an Chomhairle i. Notice is hereby given that Galway County Council pursuant to Section 20 of the Planning and Development Act 2000 (as amended), Article 14 A-E of the Planning & Development (Strategic Environmental Assessment) Regulations, 2004 (as amended), Article 6 of the EU Habitats Directive (92/43/EEC) and the Birds Directive (79/409/EEC) as amended, and the European Communities (Birds and Natural Habitats) Regulations, 2011 (S.I. 477) has prepared a Draft Local Area Plan (LAP), Local Transport Plan (LTP), a Strategic Environmental Assessment (SEA) Environmental Report, an Appropriate Assessment (AA) Stage 2 Natura Impact Report and also a Strategic Flood Risk Assessment (SFRA) for Gort.

The Draft Local Area Plan along with the reports outlined above will be on public display and may be inspected from Thursday 9th January 2025 to 4pm Thursday 20th February 2025 (excluding weekends and public holidays) at the following locations:
