PEDESTRIAN CROSSING, L-3107-0, CAHEROYN, ATHENRY

Under Section 38 of the 1994 Road Traffic Act, a Road Authority may in the interest of the safety and convenience of road users provide such traffic calming works as it considers desirable in respect of a public road in its charge. Galway County Council proposes to implement a Pedestrian Crossing at the following location:

- L-3107 – Caheroyn, Athenry.

The works will involve installation of; a pedestrian crossing at grade with road surface with associated belisha beacons, lighting, skid resistant surfacing, road markings and signage.
