Under Section 38 of the 1994 Road Traffic Act, a Road Authority may in the interest of public safety and convenience of road users provide such traffic calming works as it considers desirable in respect of a public road in its charge.

Galway County Council are now inviting submissions from the public on the proposed Safe Routes to School Schemes at the following locations:

- R336 at Inverin, Co Galway (for Scoil Sailearna)
- R336 at Furbo, Co Galway (for Scoil Na bhForbacha)

Further information including drawings, which illustrate the proposed works for both schemes, are available online on <https://consult.galway.ie/> where separate portals will be available for each scheme from Friday 6th Feb 2026 at 12:00pm to Friday 20th Feb 2026 at 12:00pm. ### Loughrea Municipal District – Kinvara

Notice is hereby given that Galway County Council has made an order closing sections of the following routes from 10:30 a.m. to 3:00 p.m. on Saturday 7th March 2026 to facilitate a full marathon, half marathon and 10 km road race.

- 2km section of the N67
- L-8586, Carrownamaddrá, Cartrontrrellick
- L-8570, Kinvara Quay
- L-8587, Trellick
- L-4508, Killinny Road from Kinvara to Rockpark
- L4507, New Line Road between Rockpark and Funshin More
- L-8588, Moy Road
- L-8589, Cappagh Beg and Ardnagno
- L-8545, Ballybuck South

**Note:** Race Management Plan and associated Traffic Management Plan for the event should be consulted for exact road closures and times.

### Alternative route:

Access via Loughcurra, Turloughkeeloge, Cahermore, Ballynastaig, Kilmoran, Cappanapisha, Lissnagreeny, Clooneen, Ballymulfaig and Rockpark to the East of the race routes and the N67 to the bottom of the Corker Hill and through Leagh South to the West of the routes.

### Loughrea Municipal District

Notice is hereby given that Galway County Council proposes to make an order closing the following routes from 10:00 a.m. to 5:00 p.m. on Sunday 2nd August 2026 to facilitate hosting of triathlon event in Loughrea;

- R351 from its junction with Cross Street (L-4213) and Moore Street (L-8280) at the Farranalynch Roundabout to its junction with the L-4214 at Earlspark
- L-4214 – From its junction with the R351 at Earlspark to its junction with the L-4216 at Killeenadeema

**Note:** Race Management Plan and associated Traffic Management Plan for the event should be consulted for exact road closures and times.

### Alternative route:

Travelling from Loughrea traffic will be diverted to the L-4213 - "Tynagh Road" – for 4km, turning right onto the L-8224 at the Glendaslat Junction. Continue on this road until arriving at the R351.

Travelling from Woodford traffic will be diverted to the L-4215, continuing past "Killeenadeema Cross" until arriving at the R380.
