## Overview

Galway County Council in conjunction with The National Transport Authority and An Taisce Green Schools aims to provide a Safe Routes to School Scheme (SRTS) for Scoil Sailearna, Inverin. This school was successful with their application in 2021 for inclusion in the SRTS programme. The project aims to provide a range of measures designed at providing safer access to the school by enhancing local infrastructure, providing safer crossing points, and highlighting the school zone.

## Background

The Safe Routes to School (SRTS) Programme is a programme devised by the National Transport Authority (NTA) in partnership with Green Schools, An Taisce. The programme was developed in 2020 to satisfy demand for support for schools to increase walking and cycling to school. The aims of the programme are to improve safety at the school gate by providing 'front of school' treatments to alleviate congestion and improve access, improve access routes to school by improving walking and cycling infrastructure, and increase the number of students who cycle to school by expanding the amount of cycle parking. The works are categorised into two groups: front of school measures and routes to school measures and can include visibility improvements in the School Zone and Gateway Areas, new/upgraded walking and cycling infrastructure, safer pedestrian crossing points, junction treatments, upgrades to existing school entrances, and improvements to permeability links

## Scheme Location

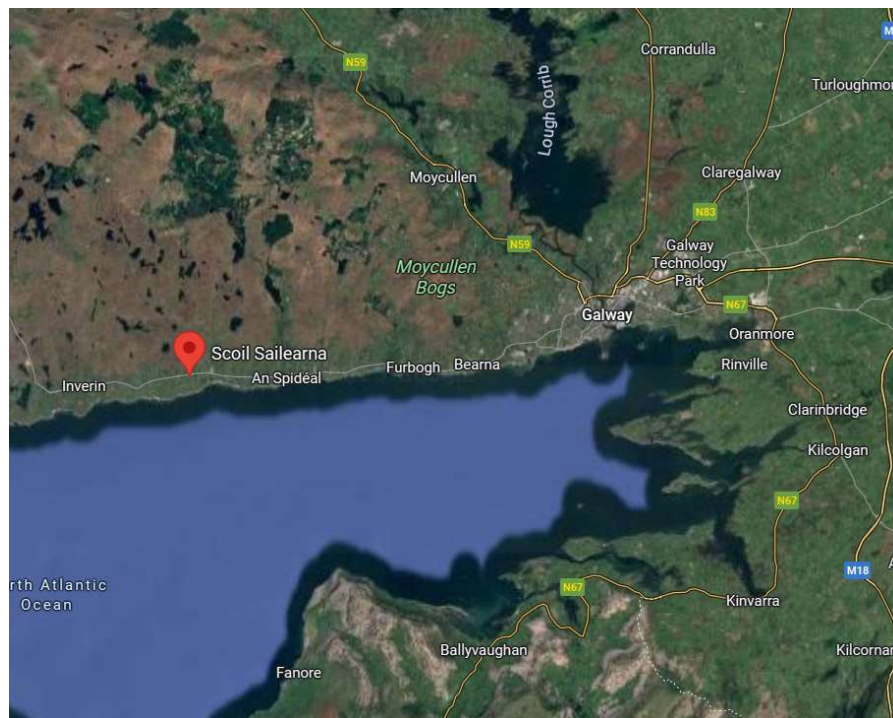


Fig 1- School Location

This scheme is located on R336, Inverin, Co. Galway. Fig 1 below illustrates the School's location in proximity to Galway city.

## Project Objectives

The primary objectives for this Project are as follows:

- To provide safer access at the main entrance to the school
- To increase road safety and driver awareness within the vicinity of the school
- To provide for better permeability linkages between schools and other trip generators
- To highlight the presence of the school zone
- To serve a reminder to drivers of the periodic speed limits, when in activation
- To reduce vehicular speeds adjacent to the school

## Summary of Proposed Measures

Design proposals for **Scoil Sailearna** can be summarised as follows:

- Introduction of a raised table signalised pedestrian crossing on R336.
- Introduction of additional Periodic Speed Limit signs between Scoil Sailearna and Coláiste Cholmcille
- Junction tightening at the entrance to the school to slow vehicular movements entering and exiting onto the R336.
- Junction tightening and provision of an uncontrolled crossing on side road opposite the school.
- Introduction of a safe congregation area directly outside the school.
- Highlighting the school zone by use of Safe Routes to School signage, road markings and pencil bollards.
- Localised carriageway narrowing to provide sufficient pedestrian refuge on the South side of the pedestrian crossing.
- Introduction of bus-bay markings within school to ensure school's requirements are met.

Design proposals for Scoil Sailearna are illustrated in the drawing attached to this consultation.

## What has been done so far?

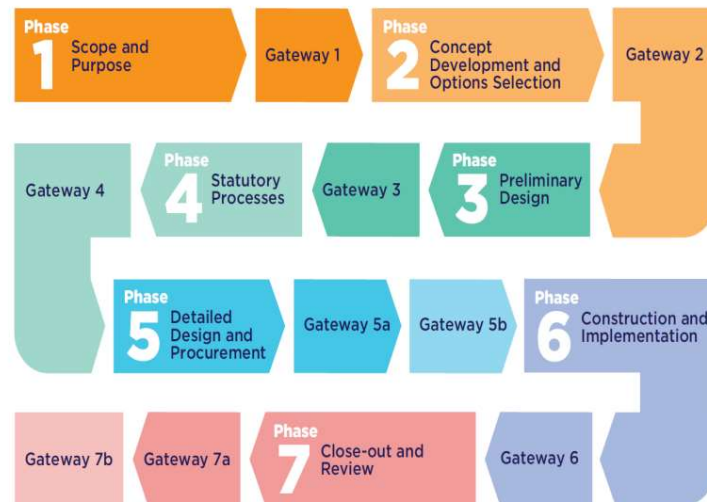


Fig 2- NTA's Project Approval Process

We are currently in Phase 2 (Gateway 2/3 approval) of a 7 stage NTA Project Approval Process. Fig 2 below illustrates the 7 stages of this process.

## What happens next?

This is Phase 2/3 combined of the process of the NTA project cycle, Non statutory consultation stage of the project.

The current Preliminary drawings having been derived from some recommendations noted in An Taisce's Outline Delivery Plan for this school and subsequently workshopped with NTA. They will be finalised following this public consultation where they will be then subject to a series of Quality and Safety audits to eventually reach Gateway 3 approval. These drawings, including any revisions will then be publicised again requesting public feedback (over a 2-week period which will be advertised) under Section 38 of the Road Traffic Act, 1994.

All measures noted are subject to funding.
